Three core courses for all teacher candidates prepare them to teach diverse learners effectively. They include: Educational Measurement and Assessment, Classroom Management and Behavior and Adaptations and Modifications for Learning.

Look Ahead Lakers program, a college access program for fifth through twelfth graders, gives teacher candidates the opportunity to role model and mentor at risk students. Both one field experience in a documented 30% ethnic diverse population and one week practicum directly working with special education personnel and students with identified IEPs are required. Preparation for the edTPA requires candidates to justify their instruction and planning to meet the needs of all learners.

All teacher candidates are required to take a course entitled Using Information Technology. In 2014-15 teachers and students used Moodle (Joule), a course management system to collect, manage and analyze data for the improvement of instruction. All teacher candidates are expected to apply the principles of universal design to lessons in the core course of Adaptations and Modifications. Added a Technology and Media course to the core curriculum in the spring of 2012. All candidates prepare an e-portfolio demonstrating their competencies in the teacher standards. We are preparing candidates to complete the edTPA giving our institution program improvement data. Silver Lake College is embarking on implementing a data system called Jenzabar.
